Group English program, including group conversation class and language lab. We have a rolling admissions process. Minimum enrollment is 1 month. Maximum enrollment is 12 months. All prices listed are in United States dollars (US\$). All prices are subject to change. All bookings subject to availability and confirmation. All students must be 16 years old or older by the inlingua program start date.

OPTIONAL F-1 APPLICANT FEES: In addition to inlingua's tuition and fees, interested international student applicants can pay the \$200 I-901 (SEVIS) Fee (non-refundable) to inlingua to be processed for the student and a \$100 courier fee (non-refundable) to mail the Form I-20 and acceptance materials.

Your *Annual Registration Fee* and *Quarterly Services Fee* include all books and materials for each quarter, a student ID Card, and yearly access to the following: inlingua's online learning system, center library, Wi-Fi, unlimited coffee/tea/water, student lounge and/or kitchenette, and in-school activities.

GPIP: UNDERSTANDING YOUR PAYMENT OPTIONS AND INLINGUA REFUND POLICIES

GPIP TUITION

ilingua provides instruction and charges tuition for the *General Purpose Immersion Program* (GPIP) **by the month**, and one academic quarter is 3 months. Due to the length and structure of this program, you cannot enroll for fewer than 1 or more than 12 months. When you enroll in this intensive English program, you can select **TUITION PLAN A** (for 12 consecutive months), **TUITION PLAN B** (for 4 consecutive months), or **TUITION PLAN C** (for between 1 and 12 months at a time).

ilingua recommends that students select the tuition option that best meets their personal and financial needs. When you choose to pay the tuition in full, you receive a discounted tuition price compared to the regular monthly tuition rate, but you risk losing prepaid tuition if you exit the program early (no refund). When you choose to pay as you go, you pay the regular monthly tuition rate but do not lose any prepaid tuition if you exit the program early.

PAYMENT OPTIONS (see attached price sheet)

When you enroll in this intensive English program, you are able to prepay 100% of your tuition and fees (applies to Plans A and B), prepay 100% of your tuition and the first *Quarterly Services Fee* (applies to Plans A and B), or pay as you go with the monthly PLAN C. To study more than 1 month with PLAN C, you need to complete an agreement to authorize future payments. The remaining balance is paid as you go for each month of tuition until the balance is paid in full. Each monthly payment is due by the fifth day of the month.

GPIP FEES

In order to enroll in the inlingua GPIP, all students need to pay a non-refundable **Annual Registration Fee** of \$150 once per calendar year (12 months) and a **Quarterly Services Fee** of \$50 for each academic quarter for the duration of the enrollment (e.g., \$50 for an 1 quarter, \$100 for 2 quarters, \$150 for 3 quarters, and \$200 for 4 quarters).

OPTIONAL FEES FOR F-1 STUDENTS

International students (initial attendance F-1 visa application or an application for change of status to F-1) have to pay a government fee (the \$200 **I-901 SEVIS Fee**). Students are able to pay this directly to the government or pay inlingua to process this payment to the government. At the time of application, these students can pay the optional \$200 fee (non-refundable) for inlingua to send the **I-901** receipt to the student. International students are able to collect documents in person at the inlingua center or pay the optional \$100 **Courier Fee** (non-refundable) to mail the documents.

REFUNDS (See the terms and conditions for full details).

You are entitled to a refund when you:

Amount of Refund

1. are denied admission to by inlingua. →	All prepaid tuition and unused non-refundable fees (Courier and government fees are not refunded)
2. cancel the enrollment - in writing - within the first 3 calendar days of signing the inlingua enrollment form. →	All prepaid tuition and unused non-refundable fees <u>or</u> your balance due will be terminated after the refund is processed (Courier and government fees are not refunded)
3. cancel the enrollment - in writing - after the first 3 calendar days of signing the inlingua enrollment form <u>but before the scheduled start date</u> (Plans A and B only). →	Prepaid tuition minus the equivalent cost of tuition for 1 academic quarter (defined as 3 months calculated by the regular PLAN C monthly rate for the center of study)
4. enroll for longer* than you need to complete/graduate from the program. *This can happen when you enter the program at the highest level (level 5 takes 3 months to complete) and have prepaid for more than three months of tuition. →	PLANS A and B - full refund of all prepaid tuition for the months you will be unable to use PLAN C – no refund but balance due will be terminated
5. are denied an F-1 visa by the U.S. embassy or consulate (student applying from abroad) <u>or</u> are denied a change of status to F-1 by the U.S. government (student applying from within the U.S.). →	Refund of prepaid tuition *Denial letter from the government is required for the refund to be processed.
